- Established 8/14/34
- National City Bank in Chicago acquired Century Bank of Chicago (11/19/65)
- Merged without assistance into U.S. Bank 9/5/97 – then renamed Manufacturers
 - Manufacturers Bank acquired Peterson Bank (6/14/97)
 - Manufacturers Bank acquired National City Bank in Chicago (4/1/69)

Peterson Bank

- Established 3/16/70
- Assets \$198 million
- Acquired in 1995 by Manufacturers National Corporation
- Merged without assistance into Manufacturers Bank 6/13/97

U.S. Bank

- Established 2/3/45
- Manufacturers Bank acquired U.S. Bank (1995)
 - Steel City Bank of Chicago renamed to U.S. Bank (8/22/94)
- Manufacturers Bank acquired U.S. Bank's charter (1995)
- The Mid-City National Bank of Chicago survivor of merger with Manufacturers

Manufacturers Bank

- Mid-City's Charter survives merger Manufacturers Charter 11/7/01
- Manufacturers Bank acquired First Savings and Loan Association of South Holland (5/16/01)

Avondale Federal Savings Bank

- Renamed from Avondale Federal Savings and Loan Association 5/19/83
- Merged without Assistance into Manufacturers Bank 3/5/99

First Savings and Loan Association of South Holland

- Established 7/31/59
- Assets \$218 million
- Merged without assistance into Manufacturers Bank 5/15/01

The Mid-City National Bank of Chicago

- Assets \$928 million
- Mid-City Trust and Savings Bank organized 4/5/11
- Iroquois Corporation acquired 12/3/73
- Mid-City National Bank changes name to The Mid-City National Bank of Chicago in 1984
- Mid-City acquires Manufacturers Bank - charter survives merger of equals
- The Mid-City National Bank of Chicago, has been renamed MB Financial Bank, National Association 2001

First National Bank of Morton Grove

- Established in 1951
- Assets \$323 million
- Merged without assistance into Mid-City 11/7/01

First National Bank of Elmhurst

- Established in 7/1/69
- Assets \$171 million
- Merged without assistance into Mid-City 11/7/01

Damen National Bank

- Established 1/1/16
- Assets \$207 million
- Merged without assistance into Mid-City 7/2/99

Peoples Federal Savings and Loan Association

- Established 1/1/12
- Assets \$26 million
- Mid-City National Bank of Chicago acquired Peoples Federal Savings and Loan Association 4/11/95

Clyde Federal Savings and Loan Association

- Established 1/1/14
- Assets \$574 million

Clyde Federal Savings Association

- Established 2/2/90
- Assets \$336 million
- Merged with Financial Assistance into Mid-City 5/31/99

The First National Bank of Lincolnwood

- Established 10/15/55
- Assets \$227 million
- Merged without assistance into MB Financial Bank, N.A. 4/5/02

South Holland Trust & Savings Bank

- Established 12/14/11
- Assets \$558 million
- Merged without assistance into MB Financial Bank, N.A. 5/15/03

First Security Federal Savings Bank

- Established 1/1/26
- Assets \$558 million
- First Security Federal Savings Bank acquired Ukrainian Federal Savings and Loan Association of Philadelphia, PA 6/25/94
- Merged without assistance into MB Financial Bank, N.A. 7/22/04

Oak Brook Bank

- Established 4/18/62
- Assets \$2.3 billion
- Acquired First National Bank and Trust Company of Oak Brook 5/1/1986
- Acquired First Oak Brook Bank – DuPage 4/1/1988
- Acquired 1st Oak Brook Bank 8/29/1994
- Merged without assistance with MB Financial Bank, N.A. 11/02/06

Heritage Community Bank

- Established 11/28/69
- Assets \$226 million
- Acquired Co-operative Federal Savings Bank 12/13/91
- Acquired Riverdale Bank 11/3/1994
- Merged with government financial assistance and subsequently operated as part of MB Financial Bank, N.A. in Chicago, Illinois, 2/27/09

InBank

- Established as Interstate Bank of Oak Forest 6/25/1970
- Assets \$212 million
- Merged with government financial assistance and subsequently operated as part of MB Financial Bank, N.A. in Chicago, Illinois, 9/4/09

Corus Bank

- Established as Aetna State Bank 12/31/1913
- Assets \$7 billion. \$3 billion assumed by MB
- Merged with government financial assistance and subsequently operated as part of MB Financial Bank, N.A. in Chicago, Illinois, 9/11/09

Benchmark Bank

- Established as Verona Exchange Bank 1/1/1888
- Assets \$170 million
- Merged with government financial assistance and subsequently operated as part of MB Financial Bank, N.A. in Chicago, Illinois, 12/4/09

Broadway Bank

- Established 5/7/1979

New Century Bank

- Established 1/11/1999
